AND WHEREAS, it is deemed expedient to amend said By-Law No. 07/1902 to provide for the issuance of the aforesaid borrowing;

NOW THEREFORE, the Council of the Town of Carman, in council duly assembled, hereby enacts as follows:

- 1. THAT By-Law No. 07/1902 of the Town of Carman BE AND THE SAME IS **HEREBY AMENDED** to provide that borrowing in the amount of \$575,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 30th day of November, 2007, to bear interest at the rate of 5.75% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2008 to 2022, both inclusive.
- 2. THAT the issue of said borrowing provides financing for all costs of works completed under authority of By-Law No. 07/1902, and the balance of \$275,000.00 of authorized borrowing which will not be required or used is hereby cancelled.
