

**TOWN OF CARMAN
BY-LAW NO. 08/1926**

Being a by-law of the Town of Carman for the purpose
of authorizing remuneration to Council appointed committee members

WHEREAS, Section 124(2) of *The Municipal Act* provides that a council may by by-law set the types, rates and conditions of payments to be made to or on behalf of members of the council and council committees, other than the committee of a local urban district,

- a) as compensation for attending to municipal business;
- b) for expenses incurred while attending to municipal business; and
- c) for any other purpose relating to municipal business that the council consider appropriate.

AND WHEREAS, Section 124(3) of *The Municipal Act* provides that a member of a council or council committee may be paid and may accept an amount paid under a by-law passed under subsection (2);

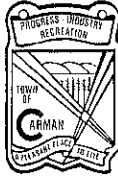
AND WHEREAS, Section 124(4) of *The Municipal Act* provides that the annual financial statements of a municipality must show the amount of compensation, expenses and any other payment made to each person who is a member of the Council or a council committee in sufficient detail that the type of each payment and the total amount of payments made to or on behalf of each member can be determined;

AND WHEREAS certain council appointed committee members of the Town of Carman do not receive compensation or remuneration for attendance at regular or special meetings of the boards or commissions;

AND WHEREAS the Council of the Town of Carman deems it to be in the best interests of the Town to authorize such payments to council appointed committee members;

NOW THEREFORE BE IT ENACTED as a by-law of the Town of Carman as follows:

1. **THAT** Citizen Members appointed by the Council of the Town of Carman to the
 - a) Carman Dufferin Recreation Commission
 - b) Carman Community Health Board
 - c) Boyne Regional Library
 - d) Boyne River/Stephenfield Lake Advisory Board
 - e) LaSalle Red Boine Conservation Districtbe allowed the following

- (i) remuneration of twenty-five (\$25.00) for each regular meeting of the organization in the performance of his or her duties on the board, commission or committee;

2. **THAT** this remuneration is allowable only if the board, commission or committee does not pay the aforementioned remuneration.

3. **THAT** payment of the remuneration and vehicle expense shall be made upon receipt of a statement from the committee member to the Town of Carman in December of each year. The said statement to be submitted by the committee member to Council annually is attached to this by-law as Schedule "A".

4. **THAT** this by-law shall take effect January 1, 2009.

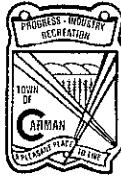
