

RURAL MUNICIPALITY OF DUFFERIN

By-Law #1600

Re: Road Opening & Bridge Construction  
on East of S.W. 1/4 25-6-5 W.P.M.

WHEREAS Section 212(4) of the Municipal Act provides as follows:  
"A municipality may acquire, by expropriation or otherwise,  
lands required for a highway"  
and

WHEREAS Section 215 (1) provides in part, as follows;  
"The council of a municipality may pass by-laws  
(a) for opening.....improving, constructing, repairing,  
widening, or enlarging any highway"  
and

WHEREAS Section 218(1) of the Municipal Act provides, in part, as follows:  
"Any municipality, if so authorized by a by-law of the council  
thereof, may construct and maintain a bridge over any highway  
in the municipality where it crosses any river....."

AND WHEREAS it is deemed expedient and in the best interest of the municipality that all that portion of the South-West Quarter of Section 25, Township 6, Range 5, West of the Principal Meridian in Manitoba, as shown upon a plan of survey made by Wilson & Neal, Manitoba Land Surveyors on the 6th day of July, 1990, and sworn to by him on the 14th day of September, 1990, be purchased, opened to the public for a public road and a bridge constructed on the said property across the Boyne River;

NOW THEREFORE BE IT AND IT IS HEREBY PASSED AND ENACTED AS A BY-LAW OF THE RURAL MUNICIPALITY OF DUFFERIN, IN COUNCIL DULY ASSEMBLED, AS FOLLOWS:

1. That the above mentioned property be purchased from Mr. Sjoerd Nap, Carman, Manitoba, at a cost of \$1,000.00;
2. That a highway be and is hereby opened and established over, upon, and across the land described as follows:  


All that portion of the South-West Quarter of Section 25, Township 6, Range 5, West of the Principal Meridian in Manitoba, shown upon a plan of survey made by Wilson & Neal, a Manitoba Land Surveyor on the 6th day of July, 1990, and sworn to by him on the 14th day of September, 1990;

and the said lands are hereby dedicated to the public for that purpose.

and a bridge shall be constructed on the said property across the Boyne River.
3. That the said plan of survey is hereby adopted and approved, and the Secretary-Treasurer is authorized and directed to endorse the aforementioned plan of survey for identification, placing thereon his signature, under the corporate seal of the Municipality, together with a reference by-law.

PASSED AND ENACTED by the Rural Municipality of Dufferin in Council duly assembled, this the 6th day of November, 1990 A.D.
