

THE RURAL MUNICIPALITY OF DUFFERIN

By-Law No. 1627

A by-law of the Rural Municipality of Dufferin to provide and authorize the remuneration of and payment of certain expenses to members of the Council of the Rural Municipality of Dufferin in the year A.D. 1992.

WHEREAS the Municipal Act, R.S.M. 1998, C. M225, Part III, Division II, Subdivision VI, provides for the remuneration of and the payment of certain expenses to members of the council of a municipality, if a by-law of the municipality so provides;

AND WHEREAS it is deemed necessary and in the best interest of the Rural Municipality of Dufferin, by by-law, to provide for the payment of monthly indemnities, daily indemnities and certain expenses to the Reeve and each Councillor of the Rural Municipality of Dufferin in the year A.D. 1992;

NOW THEREFORE the Council of the Rural Municipality of Dufferin in regular session assembled, ENACTS AS FOLLOWS:

1. That, pursuant to the provisions of Subsection (1) of Section 110 of the Municipal Act,
 - (a) the Reeve shall be paid an annual indemnity of four thousand dollars (\$4,000.00), and
 - (b) each Councillor shall be paid an annual indemnity of three thousand dollars (\$3,000.00).
2. That pursuant to the provisions of Subsection (2) of Section 110 of the Municipal Act, the Reeve and each member of Council shall be paid:
 - (a) Twenty-eight cents (\$.28) for each kilometer, each way, from his place of residence in the municipality to the place of meeting and return to his place of residence, to be allowed only once for each meeting.
 - (b) Eight dollars (\$8.00) per hour for each hour actually and necessarily spent by him under authority previously given by resolution of council, in the performance of such duties, work or services as he is required or authorized under resolution to perform. A maximum of 600 hours will be paid out of the general fund and any amount over 600 hours will be paid from the individual ward.
 - (c) Twenty-eight cents (\$.28) for each kilometer or forty-five cents (\$.45) for each mile actually and necessarily travelled by him in the performance of duties, work or services to which clause (b) applies, but the remuneration or mileage mentioned in clauses (b) and (c) is not payable until an account showing the work or services performed, verified by statutory declaration, has been filed with the Clerk and payment thereof authorized by resolution of the Council. A maximum of 6000 miles per year will be paid out of the general fund and any amount over 6000 miles will be paid from the individual wards.
3. That pursuant to the provisions of Subsection (1) of Section III of the Municipal Act, each member of Council, if duly authorized by resolution of Council, specifying the purpose of the journey, to go on a specific journey beyond the limits of the corporation on business thereof, shall be paid:
 - (a) his actual travelling expenses, and his actual living costs, and
 - (b) an indemnity of Sixty Dollars (\$60.00) for each day he is actually engaged in that business and Thirty Dollars (\$30.00) for evenings spent out of the municipality;

4. That pursuant to the provisions of Subsection (4) of Section 111 of the Municipal Act, all members of the Council, if duly authorized by resolution of Council, to attend a meeting of

- (a) Manitoba Association of Urban Municipalities
- (b) Union of Manitoba Municipalities, or
- (c) The Canadian Federation of Mayors and Municipalities, or other such organizations that in the opinion of the Council is in the best interest of the municipality to belong;

shall be paid

the actual travelling expenses

and


an indemnity of One Hundred and Twenty Dollars (\$120.00) for each day he is actually engaged in travelling to, attendance at, and returning from such meetings

and


lodging only.

5. That the words "actual travelling expenses" when they apply to a member of the Council travelling in a private motor car owned by him or operated at his expense, shall be deemed to mean twenty-eight cents (\$.28) per kilometer, each way, from his place of residence in the Rural Municipality of Dufferin, to the place or places at which the business was conducted or the meeting attended.
6. That the annual indemnity to which reference is made in Clause (1) is to be paid monthly, or at such less frequent intervals as may be indicated by each individual member of Council.
7. That the indemnities and expenses to which reference is made in Clauses 2, 3,4 and 5 shall be paid each month subsequent to the submission thereof to the committee on finance.
8. That this by-law shall come into force and take effect on the last day of January A.D. 1992.
