RURAL MUNICIPALITY OF DUFFERIN

By-Law No. 1697

WHEREAS Section 888 of the Municipal Act provides authority to cancel in whole or in part any taxes owing to the Municipality;

AND WHEREAS the Council of the Rural Municipality of Dufferin considers it is in the best interest of the Municipality to cancel the hereinafter specifically mentioned taxes owing to the municipality;

NOW THEREFORE the Council of the Rural Municipality of Dufferin in Council, duly assembled, doth enact as follows:

THAT the Real Property taxes described in Schedule "A" annexed hereto and amounting to a total sum of \$3,271.30 which said schedule forms a part of by-law no. 1697 and the same are hereby cancelled.

THAT this by-law, together with evidence of bona fides, be submitted to the Minister forthwith, and when the same by-law is approved and takes effect, that all things done and entries made to give effect to the provision of same.

THAT no entry of any cancellation affected by this by-law shall be made in the records of the municipality until the Minister of Rural Development has certified this by-law.

THAT this by-law shall come into force and take effect when approved by the Minister.

In the matter of by-law #1697 of the Rural Municipality of Dufferin, dated the 10th day of December A.D. 1996 authorizing the cancellation of certain taxes owing to the R.M. of Dufferin.

I, William K. Roth, Reeve of the Rural Municipality of Dufferin, in the Province of Manitoba,

DO SOLEMNLY DECLARE:

1. That I am Reeve of the Rural Municipality of Dufferin.
2. To the best of my knowledge and belief, by-law #1697 passed by the Council of the Rural Municipality of Dufferin on the 10th day of December A.D. 1996 and providing for the cancellation of certain debts owing to the said municipality, is a bona fide and is in the best interest of the municipality.
