

THE RURAL MUNICIPALITY OF DUFFERIN

By-Law No. 1714

A by-law of the Rural Municipality of Dufferin to provide and authorize the remuneration of and payment of certain expenses to members of the Council of the Rural Municipality of Dufferin.

WHEREAS the Municipal Act, Section 124, provides for the remuneration of and the payment of certain expenses to members of the council of a municipality, if a by-law of the municipality so provides;


AND WHEREAS it is deemed necessary and in the best interest of the Rural Municipality of Dufferin, by by-law, to provide for the payment of monthly indemnities, and mileage expenses to the Reeve and each Councillor of the Rural Municipality of Dufferin;


NOW THEREFORE the Council of the Rural Municipality of Dufferin in regular session assembled, ENACTS AS FOLLOWS:

1. That, pursuant to the provisions of Section 124 (2) of the Municipal Act, the total annual compensation for each councillor and the Reeve shall be \$8,400.00 and shall be paid as follows:
 - 1) Twelve monthly payments of \$467.00 for a total of \$5,604.00, paid as an indemnity subject to income tax; and
 - 2) 12 monthly payments of \$233.00 for a total of \$2,796.00, paid as a non-accountable expense allowance exempt from income tax.
2. That the Reeve and each member of Council shall be paid twenty-eight cents (\$.28) for each kilometer or forty-five cents (\$.45) for each mile, each way, from his place of residence in the municipality to the place of meeting and return to his place of residence, to be allowed only once for each meeting of Council; and twenty-eight cents (\$.28) for each kilometer or forty-five cents (\$.45) for each mile actually and necessarily travelled by him in the performance of duties, work or services required with the carrying on of business and affairs and the discharge of the duties and responsibilities of the municipality.
3. That each member of the council of the R.M. of Dufferin shall be paid \$400.00 per year to reimburse council members for the cost of regular telephone and cellular telephone charges related to the carrying on of business and affairs and the discharge of the duties and responsibilities of the municipality.
4. That, pursuant to the provisions of Section 124 (2) of the Municipal Act, all members of the Council, if duly authorized by resolution of Council to attend a meeting of
 - (a) Manitoba Association of Urban Municipalities, (b) Union of Manitoba Municipalities, or (c) The Canadian Federation of Mayors and Municipalities, or such organizations that in the opinion of Council is in the best interest of the municipality to belong; shall be paid:
 - (a) the actual travelling expenses,
 - (b) an indemnity of one hundred and Twenty Dollars (\$120.00) for each day he is actually in travelling to, attendance at, and returning from such meetings, and
 - (c) lodging only.

5. That the words "actual travelling expenses" when they apply to a member of the Council travelling in a private motor vehicle owned by him or operated at his expense, shall be deemed to mean twenty-eight cents (\$.28) per kilometer or forty-five cents (\$.45) for each mile, each way from his place of residence in the Rural Municipality of Dufferin, to the place or places at which the business was conducted or the meeting attended.
6. That the indemnities and expenses to which reference is made in Clauses 1 shall be paid each month and the mileage expenditures to which reference is made in Clause 2 shall be paid annually, subsequent to the submission thereof to Council.
7. That By-Law No. 1701 & 1710 and hereby is rescinded.
8. That this by-law shall come into force after third reading.
