

THE RURAL MUNICIPALITY OF DUFFERIN  
By-Law No. 1734

A By-law of the Rural Municipality of Dufferin  
to amend By-law No. 1730

WHEREAS The Rural Municipality of Dufferin by its By-law No. 1730 which was authorized by Municipal Board Order No. E-00-074 is, inter alia, authorized to issue debentures in the amount of \$350,000.00;

AND WHEREAS The Rural Municipality of Dufferin has made arrangements to sell debentures to the Minister of Finance, Province of Manitoba in the amount of \$350,000.00 being the cost of works completed up to September 30, 2000, under the authority of said By-Law No. 1730, such debentures to be dated December 31st, 2000 to bear interest at the rate of 7.25% per annum, payable annually during their currency; and to mature on December 31st in each of the years 2001 to 2010 both inclusive;

AND WHEREAS it is deemed expedient to further amend said By-law No. 1730 to provide for the issuance of debentures as aforesaid;

NOW THEREFORE the Council of the Rural Municipality of Dufferin duly assembled, enacts as follows:

1. THAT By-law No. 1730 of the Rural Municipality of Dufferin BE AND THE SAME IS HEREBY AMENDED to provide that debentures in the amount of \$350,000.00 be issued to cover the cost of the works completed thereunder up to September 30th, 2000 such debentures to be dated the 31st day of December A.D., 2000; to bear interest the rate of 7.25% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2001 to 2010, both inclusive.
2. THAT the issue of said debenture provides financing for all costs of works completed under authority of said By-law No. 1730.
