

THE RURAL MUNICIPALITY OF DUFFERIN

By-Law No. 1736

A by-law to amend by-law No. 1732

WHEREAS the Rural Municipality of Dufferin by its By-law No. 1732 which was authorized by the Municipal Board Order No. E-00-112 is, inter alia, authorized to issue debentures in the amount of two hundred and seventy-three thousand dollars (\$273,000.00);

AND WHEREAS The Rural Municipality of Dufferin has made arrangements to sell debentures to the Minister of Finance, Province of Manitoba, in the amount of two hundred and eight thousand dollars (\$208,000.00) being the cost of the works completed up to December 31st, 2000, under the authority of By-law No. 1732, such debentures to be dated April 1st, 2001 to bear interest at the rate of 6.75% per annum, payable annually during their currency; and to mature on the 31st day of December in each of the years 2001 to 2010 both inclusive;

AND WHEREAS it is deemed expedient to further amend said By-law No. 1732 to provide for the issuance of debentures as aforesaid;

NOW THEREFORE the Council of the Rural Municipality of Dufferin duly assembled, enacts as follows:

1. THAT By-law No. 1732 of the Rural Municipality of Dufferin BE AND THE SAME IS HEREBY AMENDED to provide that debentures in the amount of two hundred and eight thousand dollars (\$208,000.00) be issued to cover the cost of the works completed thereunder up to December 31st, 2000 such debentures to be dated the 1st day of April A.D, 2001; to bear interest at a rate of 6.75% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A" hereto on the 31st day of December in each of the years 2001 to 2010, both inclusive.
2. THAT Schedule "C" attached to said By-law No. 1732 be cancelled and Schedule "C" hereto be substituted therefore.
3. THAT the issue of said debenture provides financing for all costs of works completed under authority of said By-law No. 1732 and the balance of sixty-five thousand dollars (\$65,000.00) of authorized borrowing which will not be required or used is hereby cancelled.
