

**BY-LAW NO. 1742**  
**Being a By-law of the R.M. of Dufferin**  
**To Amend Zoning By-law No. 1722, As Amended.**

WHEREAS, Section 47(2) of The Planning Act gives the Council of a municipality the power to amend a zoning by-law;

NOW THEREFORE, the Council of the R.M. of Dufferin, in meeting duly assembled enacts as follows:

That Map No.1 of the R.M. of Dufferin Zoning By-law No. 1722 be amended so that:

The southerly 660 feet of the westerly 1320 feet of the SW ¼ 27-6-5W,  
excepting public road plan 1170 MLTO(CD).

as shown outlined in a heavy broken line on the map attached hereto as Schedule "A",  
and forming part of this by-law, be rezoned

FROM: "AR" Agriculture Restricted Zone  
TO: "RR" Rural Residential Zone

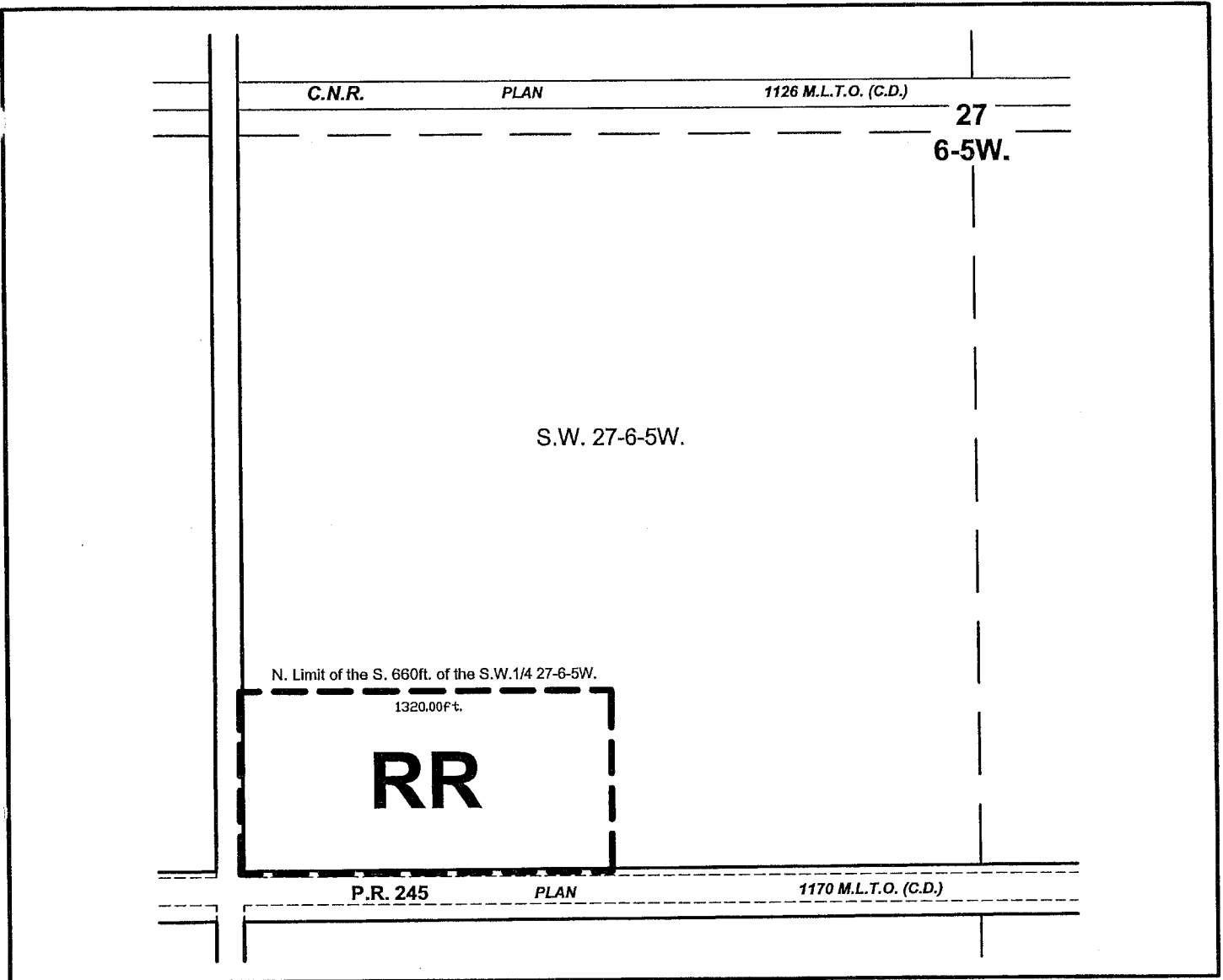

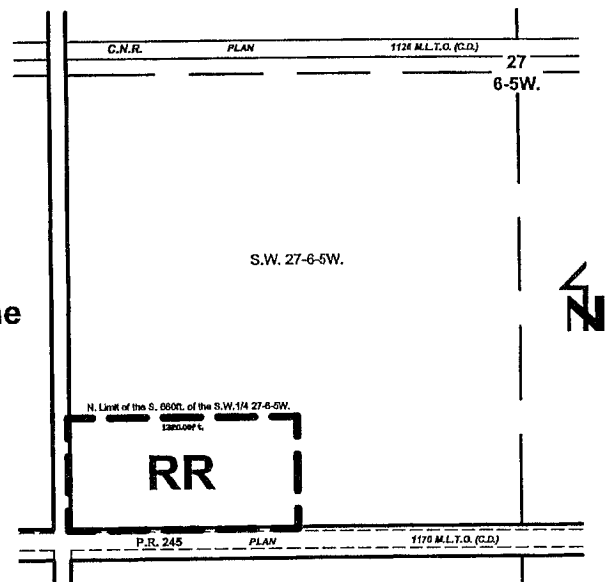
