



RURAL MUNICIPALITY OF DUFFERIN

By-law No. 1783

*Being a by-law of the Rural Municipality of Dufferin
to establish water rates within the said
Rural Municipality of Dufferin*

WHEREAS the Rural Municipality of Dufferin owns and operates a water line within the limits of the said municipality;

AND WHEREAS *The Municipal Act, S.M. 1996, C58*, states in part:

"232(1) *A Council may pass by-laws for municipal purposes respecting the following matters:*

(1) public utilities;

232(2) *Without limiting the generality of subsection (1), a council may in a by-law passed under this Division*

(d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality;"

NOW THEREFORE be it and it is hereby passed and enacted as a by-law of the Rural Municipality of Dufferin, in council duly assembled as follows:

THAT By-law No. 1682 enacted by the Rural Municipality of Dufferin the 16th day of April, 1996, and amending By-law No. 1781 enacted the 14th day of September, 2004 are hereby repealed.

THAT all accounts for minimum quarterly charges for metered services as set forth in the Schedule of Quarterly Rates shall be billed quarterly in advance together with any excess charges for metered water services for the preceding quarter. Consumers shall pay for water service supplied to them by the Rural Municipality of Dufferin at the rates and terms set out in Schedule "A" attached hereto and forming part of this by-law.

THAT this By-law shall come into force and become effective on, from and after both approval by The Public Utilities Board and receipt of third and final reading thereof.

3. Service to Customers Outside the Rural Municipality of Dufferin

(a) The council of the Rural Municipality of Dufferin may sign agreements with customers for the provision of water services to properties located outside the legal boundaries of the Rural Municipality of Dufferin for supplying water to such Municipalities, Corporations and individuals.

(b) The rates to be charged to such outside users shall be the same rates set out in the schedule, as well as a surcharge, set by resolution of council, which shall be equivalent to the frontage levy, general taxes and special taxes for utility purposes in effect at the time, or may be in effect from time to time, and which would be levied on the property concerned if it were within these boundaries. In addition, all costs of connecting to the utility mains and installing, maintaining service connections will be paid by the customer.

4. Water Allowance Due to Line Freezing

That in any case, where, at the request of the Council, a customer allows water to run continuously for any period of time to prevent the water lines from freezing, the charge to that customer for the current quarter shall be the average of the billings for the last two previous quarters to the same customer, or to the same premises if the occupant has changed.

5. Billings and Penalties

Accounts shall be billed quarterly and shall be due and payable at least fourteen days after the billing date. A penalty of 1¼% per month shall be charged on the dollar amount owing after the billing due date.

6. Disconnection and Reconnection of Service for Non-Payment

Service may be disconnected and discontinued immediately and without further notice if the account has not been paid within 30 days of the due date. Any service disconnected due to non-payment of account shall not be reconnected until all arrears, penalties and a reconnection fee of \$35.00 have been paid.

7. Outstanding Utility Charges are a Lien on Land

Pursuant to Section 252(2) of *The Municipal Act*, the amount of all outstanding charges for water service area a lien and charge upon the land serviced, and shall be collected in the same manner in which ordinary taxes upon the land are collectible, and with like remedies.

8. Water Used During Construction

Contractors using water in connection with the construction of buildings be charges a flat fee of \$15.00 for dwellings and \$25.00 for commercial buildings for every three month period until completion.

WATER RATES
BY-LAW NO. 1783

WHEREAS the Rural Municipality of Dufferin has applied to The Public Utilities Board for approval of By-law No. 1783 to revise the schedule of water rates of the said Municipality, and after public notice of the application - no persons signifying their desire to make representation in the matter;

AND WHEREAS the Board notes that the utility rate study which accompanied the application provided for a sum of money to be placed in a utility reserve account, and the Board therefore desires to ensure that these moneys be expended in an appropriate fashion;

AND WHEREAS the Board deems it expedient to do so;

IT IS THEREFORE ORDERED THAT:

1. By-law No. 1783 of The Rural Municipality of Dufferin BE AND THE SAME IS HEREBY APPROVED;



2. The water rates set forth in Schedule "A" hereto shall apply to all customers of the utility effective on all water consumed and on all minimum bills effective on the next billing in the normal course after the date of this Order.
3. This Order is subject to moneys being expended from the utility reserve fund only to support existing infrastructure, unless the Board has authorized the expenditure pursuant to Section 168 of The Municipal and Various Acts Amendment Act, c. 58.


