

BY-LAW NO. *604*....

A By-Law of the Town of Carman to ratify and confirm the sale by the said Town of Carman of the following Lots:-

Lots 1 & 2, in Block 9, Plan 64
Lots 7 & 8, in Block 46, Plan 112
Lots 9 to 13, in Block 46, Plan 112
Lot C, in Block 6, Plan 64
Lots 1 & 2, in Block 33, Plan 31
Lots 3 & 4, in Block 46, Plan 112
W $\frac{1}{2}$ Lots 24 to 28, in Block 1, Plan 15

Parcel No. 6 - Lots 3 & 4, in Block 46, Plan 112 in the


