

THE TOWN OF GARMAN  
BY-LAW NO. 80/1432

Being a By-law of the Town of Carman  
providing for the addition of certain  
contiguous territory to Local Improvement  
District No. 1, of the said Town.

WHEREAS pursuant to the provisions of The Municipal Act, S.M. 1970, c. 100 - Cap. M225, Part XI, Division II, Subdivision I, Section 668(1), the Council of the Town of Carman intends to add certain contiguous territory to Local Improvement District No. 1, of the said Town, as shown outlined in red on the attached map, being Schedule "A" hereto, which said Local Improvement District was created and established by By-law No. 950, and added to by By-law No. 1021 and No. 1307, as shown outlined in purple and green respectfully, on Schedule "A", and attached hereto, of the said Town,


AND WHEREAS notice of the intention to add these contiguous lands, herein described to Local Improvement District No. 1, was published in The Valley Leader, a weekly newspaper published in Carman, Manitoba, for the issues dated March 26, and April 2, April 9, and April 16, 1980;


AND WHEREAS no sufficient petition against the proposed addition of lands to Local Improvement District No. 1, has been presented to or received by the Council of the Town of Carman;

NOW THEREFORE BE IT AND IT IS HEREBY ENACTED by the Council of the Town of Carman, duly assembled, as follows:

(1) THAT all those lands, as outlined in Black on the map attached hereto, being Schedule "A" of this By-law, be and hereby are added to and do henceforth form a part of Local Improvement District No. 1, of the Town of Carman.

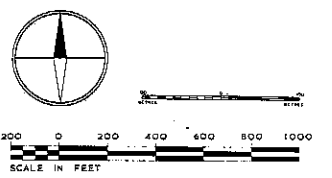
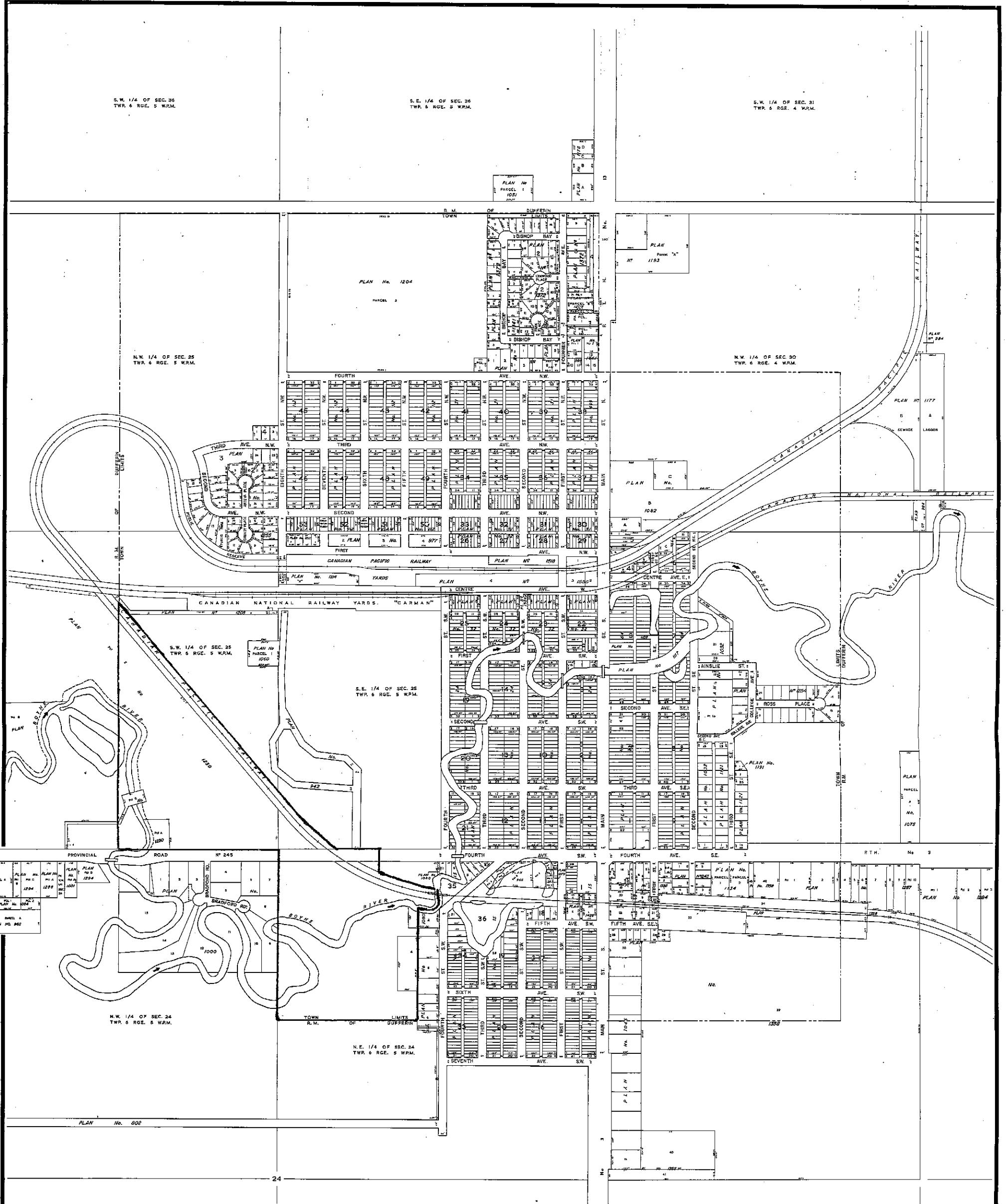
